We would like to appreciate your kind office for smooth condition of LICEs for JTO and JAO with online method. Online examinations consuming very less time and resources of BSNL. Also all examinations were conducted in fair and transparent manner.

Having said that it is bring to your kind notice that as per Standard Operating Procedures (SOP) for online examination in BSNL, candidates supposed to provide detailed answer keys immediately after successful conduction of exam. But in above said examinations for JTO (T) and JAO hold on date 22-05-2016 and 17-07-2016 respectively detailed answer keys were not provided after declaration of results by your kind office. Thus many failed candidates of these exams are complaining for ambiguity in questions, duplication of questions, multiple possible answers in given options, questions out of syllabus, not equal weightage to all topics of syllabus etc. Even question papers not provided to candidates after exam, so in the absence of questions paper and detailed answer keys, failed candidates are not in condition to raise exact grievances. Many candidates filling RTI to get answers key and wasting resources of company.

Thus your kind office requested to provide detailed answer key to all candidates as soon as possible so candidates can represent if any ambiguity is there and action can be taken by reviewing such questions as per guidelines.
